# DECLARATION

Whereas, vide preliminary notification No.26/LR&DMD/ACQ/GOS dated 13/03/2020 and Gazette Notification No.81/LR&DMD/ACQ/GOS dated 23/03/2020, it was notified under section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act 30 of 2013) that the land described in the schedule hereto (thereafter referred to as the said land) were required or likely to be required for the public purpose namely for the purpose of construction of new alignment of road from Tong to Partem-4865-Tamze by 107 RCC GREF, (GOI), in the Revenue Blocks of Tong and Naga, North Sikkim.

And whereas, based on the field report submitted by Sub-Division Office, Chungthang, the preparation of the mandated Rehabilitation and Resettlement scheme shall not be applicable because there is no displacement of family/families due to the proposed acquisition.

And whereas, as per Section 19 (I) of Right to fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the appropriate Government is satisfied that the said lands are required for public purpose.

Now, therefore, it is hereby declared under the provision of Section 19(2) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the said lands are required for the public purpose, namely for the aforementioned purpose in the aforesaid Revenue Blocks of Tong and Naga, North Sikkim.

A plan of the land can be inspected in the office of the District Collector, North District, during office hours.
