**NOTICE UNDER SECTION 11(I) OF RIGHT TO FAIR COMPENSATION AND
TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND
RESETTLEMENT ACT, 2013 (ACT 30 OF 2013).**

Whereas, it appears to the Governor that land is likely to be needed for public purpose, namely for the Construction of road for ITBP, Leema to Chu junction by Central Public Works Department, Ministry of Home Affairs, (Government of India) in the block of Lachung, North Sikkim. It is hereby notified that several pieces of land comprising cadastral Plots mentioned under the "Schedule of properties" below and measuring more or less an area of 7.4550 hectares (Private Land 3.1850 hectares) and Sikkim Sarkar, (Khasmal) 4.2700 hectares is likely to be needed for the aforesaid public purpose at public expense within the aforesaid block of Lachung, North Sikkim.
