**Partition Deed**

Partition Deed concluded between the immediate family members of the land holder ( Bustiwala) shall be allowed. The immediate family members include brothers and sisters from the same father and the children of the land holder.

Note (1) In a partition of land, a number of plots of land or part or parts of plots constituting a share of a member of a family shall be a parcel of land.

Note (2) The fee prescribed above shall be inclusive of the fees prescribed for mutation, khattian copy and copy of map as prescribed at Sl.no.1, 'a, b & c' of propage.
