PRELIMINARY NOTIFICATION UNDER SECTION 11(1) OF RIGHT TO FAIR
COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND
RESETTLEMENT ACT, 2013 (ACT 30 OF 2013)

Whereas, it appears to the Governor that land is likely to be needed for a public purpose, namely for Construction /Improvement of Singtam-Dikchu Road from km 10.00 to km 32.700 by GREF at Singbel, Dungdung, Tumin, Patuk, Rakdong, Raleykheysey, Samdong, Kambal and Tintek blocks under Gangtok District.

It is hereby notified that the several pieces of land comprising cadastral plot nos. mentioned under the "Schedule of Properties" below and measuring to a total of **6.6036 hectares** more or less (**4.9002 hectares of private land and 1.7034 hectares of Government land**) is likely to be needed for the aforesaid public purpose at public expense within the aforesaid blocks of Singbel, Dungdung, Tumin, Patuk Rakdong, Raleykheysey, Samdong, Kambal and Tintek under Gangtok District.
