PRELIMINARY NOTIFICATION UNDER SECTION 11(1) OF RIGHT TO FAIR COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT, 2013 (ACT 30 OF 2013)

Whereas, it appears to the Governor that land is likely to be needed for a public purpose, namely for construction of seven permanent bridges along Dikchu-Sangkalang road at 0.00 Km, 6.500 Km, 6.950 Km, 7.300 Km, 13.690 Km, 19.750 Km and 21.180 Km on Dikchu Sangkalang Road and 1.900 Km on Sangkalang Toong Road by Border Roads Organization 107 RCC GREF, Ministry of Defence in Revenue Blocks of Sangtok-Shagyong (lower Dzongu), Gnon Sangdong (Lower Dzongu), Hee-Gyathang (Lower Dzongu), Lingdong (Lower Dzongu), Lingthem (Upper Dzongu) and Salim-Pakyel (Upper Dzongu) North Sikkim.
